## Judith Scanlon PEF Health & Safety Activist Award

Judi Scanlon was an Intensive Case Manager and PEF member who loved her job and loved helping people. In addition to providing compassionate support to her clients, Judi was also a long time PEF activist who advocated for years for safety on the job for her co-workers. On November 24, 1998 Judi was beaten to death during a home visit to a patient, who ultimately was convicted of the murder. Even after her tragic death, Judi inspired her union sisters and brothers to find ways to change policies and procedures to protect workers, especially those in the field. *This award gives recognition to grassroots PEF H&S activists who fight for safety on the job and workers' rights.*
